

#### Terms and conditions for the use of the NK-HOSTE Wi-Fi network

#### 1) Introduction

These terms and conditions govern the terms and conditions of use of the NK-HOSTE wireless network (hereinafter referred to as "Wi-Fi") provided by the National Library of the Czech Republic (hereinafter referred to as "NLC"). By connecting to the Wi-Fi service, the user agrees to these terms and conditions.

### 2) Service provided

- The NK-HOSTE Wi-Fi service is free of charge and available to the public within the National Library of the Czech Republic.
- Access to the network is limited to the duration of the registration (30 days).
- The user is responsible for the security of his/her device while using the service.

### 3) Registration and authentication

To access the NK-HOSTE network, a one-time user registration is required to verify identity and ensure access to the service. During registration, the following information is required:

- E-mail address,
- Phone number,
- User name (nickname, does not have to be a first and last name).

The Wi-Fi service cannot be used without providing the above personal data to the NLC.

# 4) Data Protection (GDPR)

# a) Personal data controller

# b) Purpose of processing

Personal data are processed for the following purposes:

- Verification of the user's identity,
- Providing and managing the connection to the Wi-Fi network,
- Ensuring the security of the network and compliance with the rules of its use.



## c) Legal basis for processing

Data processing is necessary for the provision of Wi-Fi services (performance of a contract) pursuant to Article 6(1)(b) of the GDPR. No automated decision-making or profiling of users takes place during the processing of personal data.

### d) Retention period

Personal data will be stored for 30 days from registration, or longer in the event of repeated use of the service, but no longer than 1 year from the last connection.

### e) Transfer of data

Personal data will not be transferred to third parties, except in cases specified by law.

# f) Rights of the data subject

In accordance with the General Data Protection Regulation (GDPR), the user has the right to access their data, correct it, delete it, object to its processing, request its restriction, transferability, and the right to lodge a complaint with the Office for Personal Data Protection.

### 5) Rules for using the Wi-Fi network

- The user undertakes to use the Wi-Fi network in accordance with the laws of the Czech Republic. Use of this service of the NLC for illegal activities is prohibited.
- The NLC is not responsible for the content of the data transmitted or for any damage caused by the use of the Wi-Fi network. The user is responsible for observing the principles of safe behavior on the internet and for protecting the device used to connect to the Wi-Fi network from harmful code.
- Access to the Wi-Fi network may be restricted or terminated at any time without prior notice, in particular if the user violates these terms and conditions.
- In the event of problems with connecting to the Wi-Fi network, difficulties in operating this service, or its restriction or termination, the user shall have no claim against the NLC for compensation or restoration of the service.

#### 6) Final provisions

- By connecting to the NK-HOSTE network, the user confirms that they have read and agree to these terms and conditions.
- NLC reserves the right to update these terms and conditions at any time.
